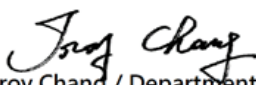

PFAS Remark :

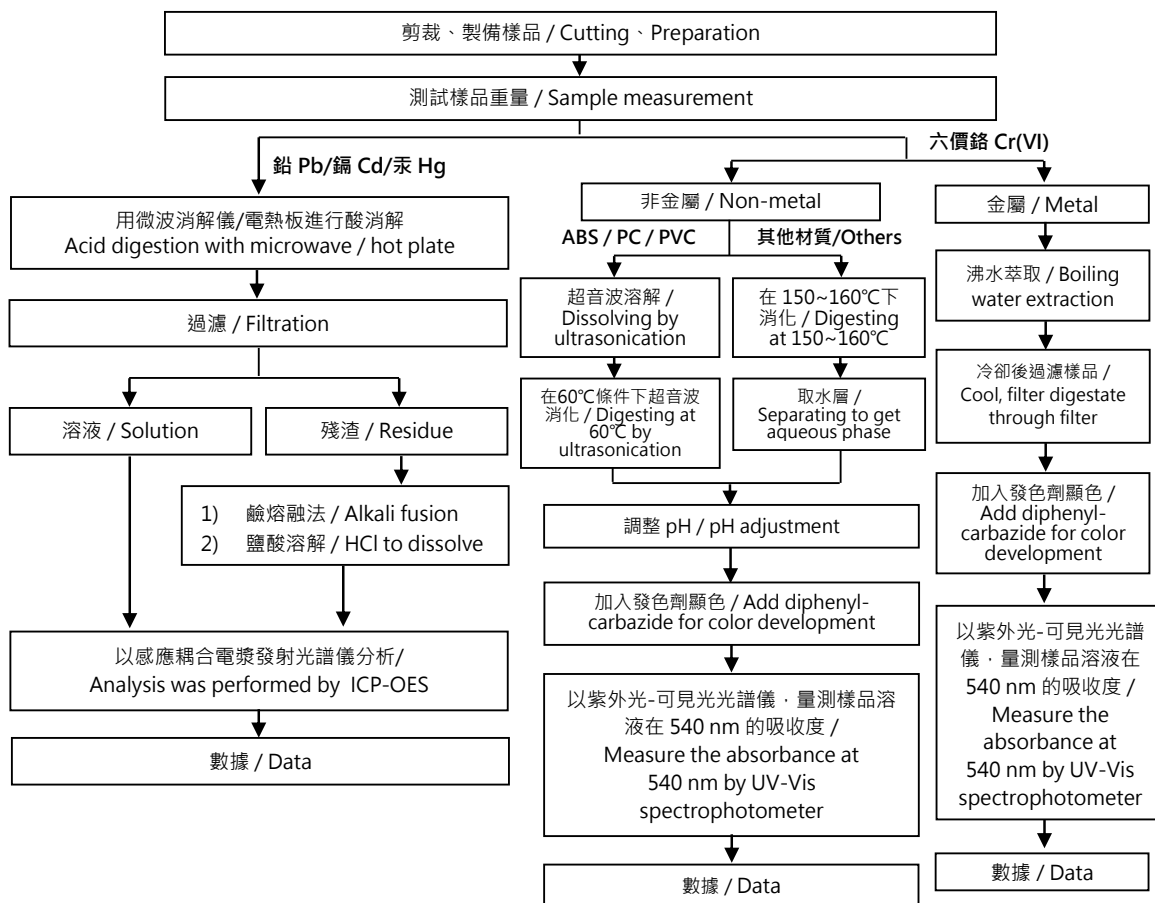

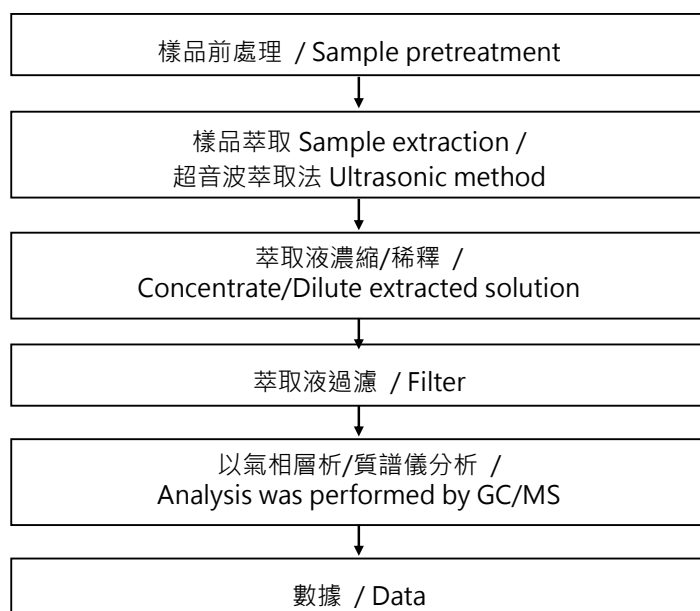

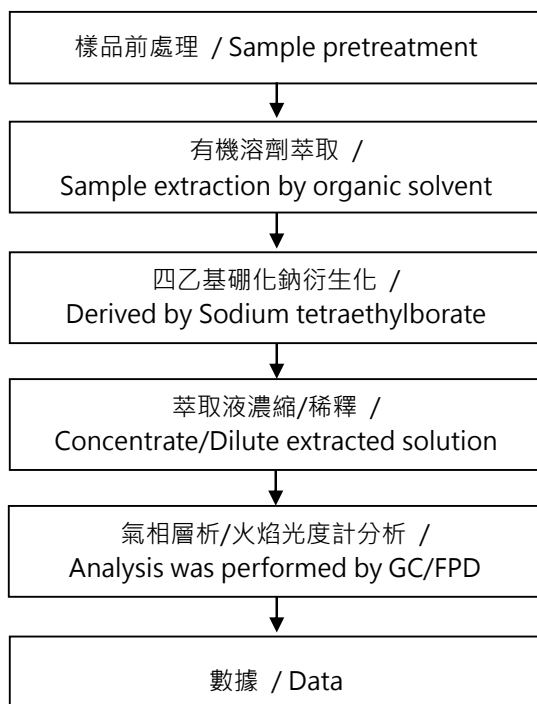

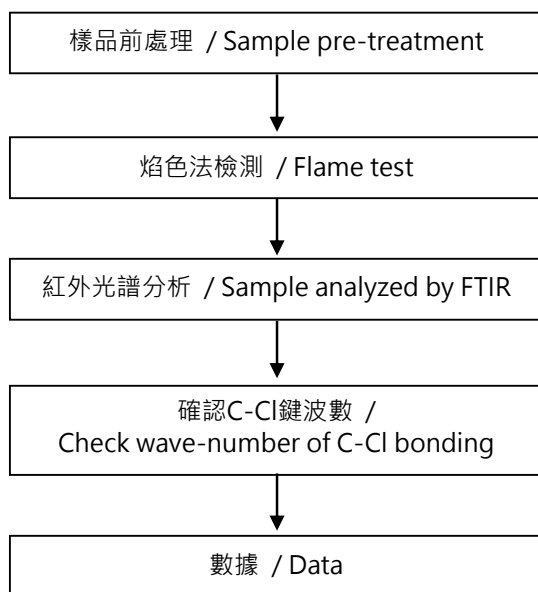

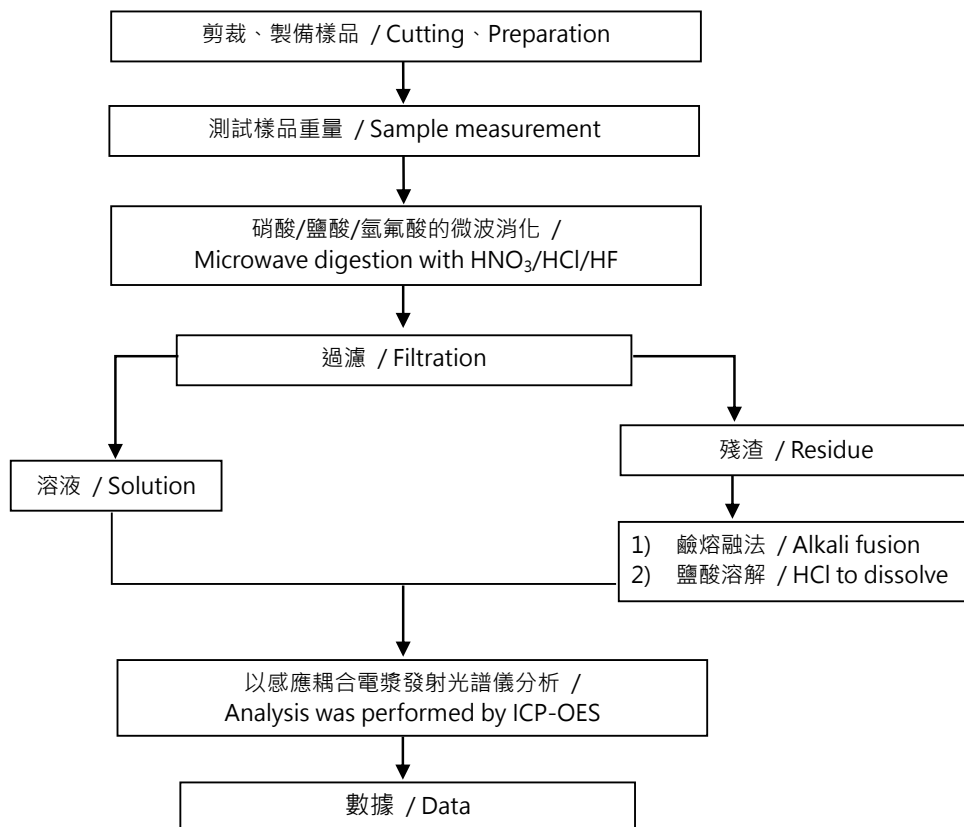
