



#### 鹵素分析流程圖 / Analytical flow chart of Halogen





#### 有機錫分析流程圖 / Analytical flow chart - Organic-Tin





#### 六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD





#### 聚氯乙烯物質判定分析流程圖 / Analysis flow chart - PVC







#### 四溴雙酚-A分析流程圖 / TBBP-A analytical flow chart





#### 雙酚A分析流程圖 / Bisphenol A analytical flow chart








