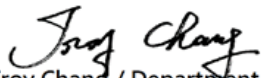

### PFAS Remark :

### 六溴環十二烷分析流程圖 / Analytical flow chart - HBCDD

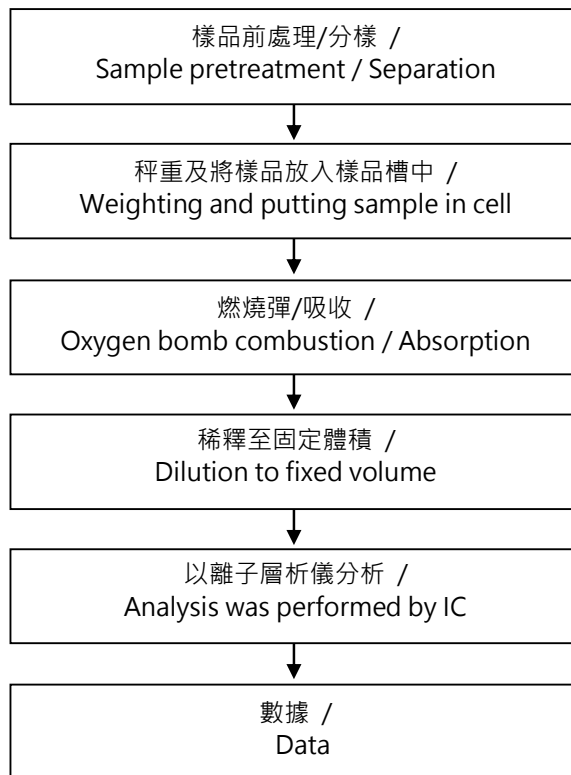

### 雙酚A分析流程圖 / Analytical flow chart - Bisphenol A



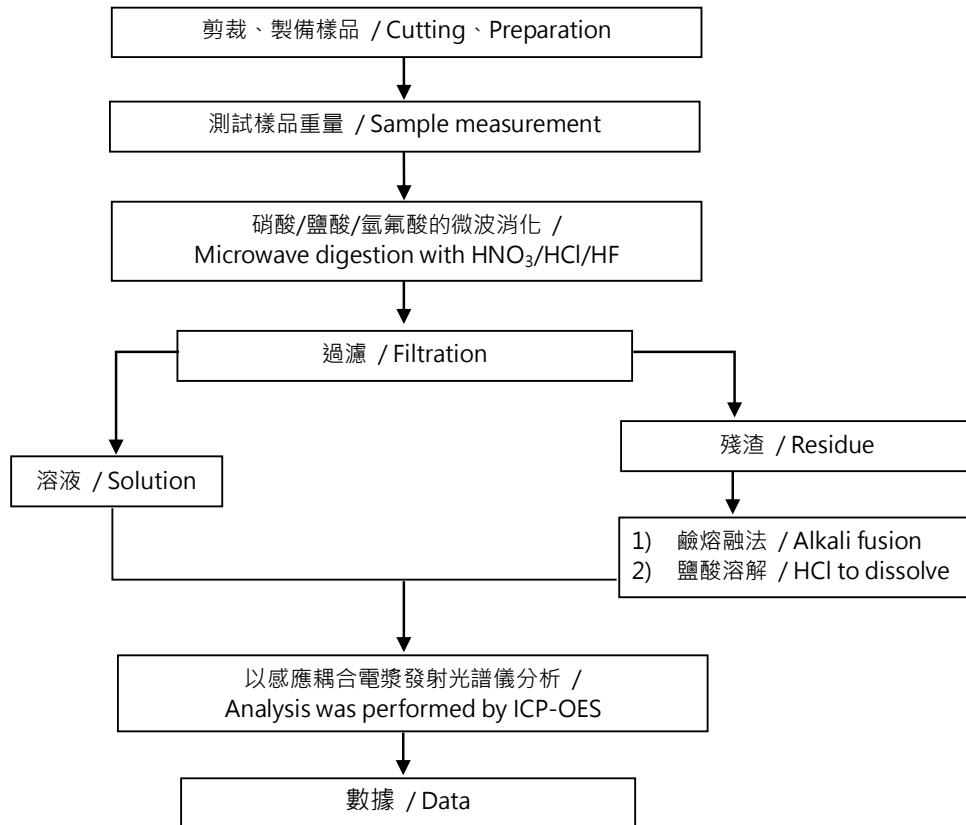
