

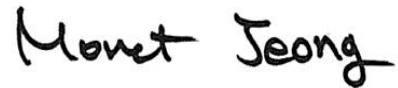

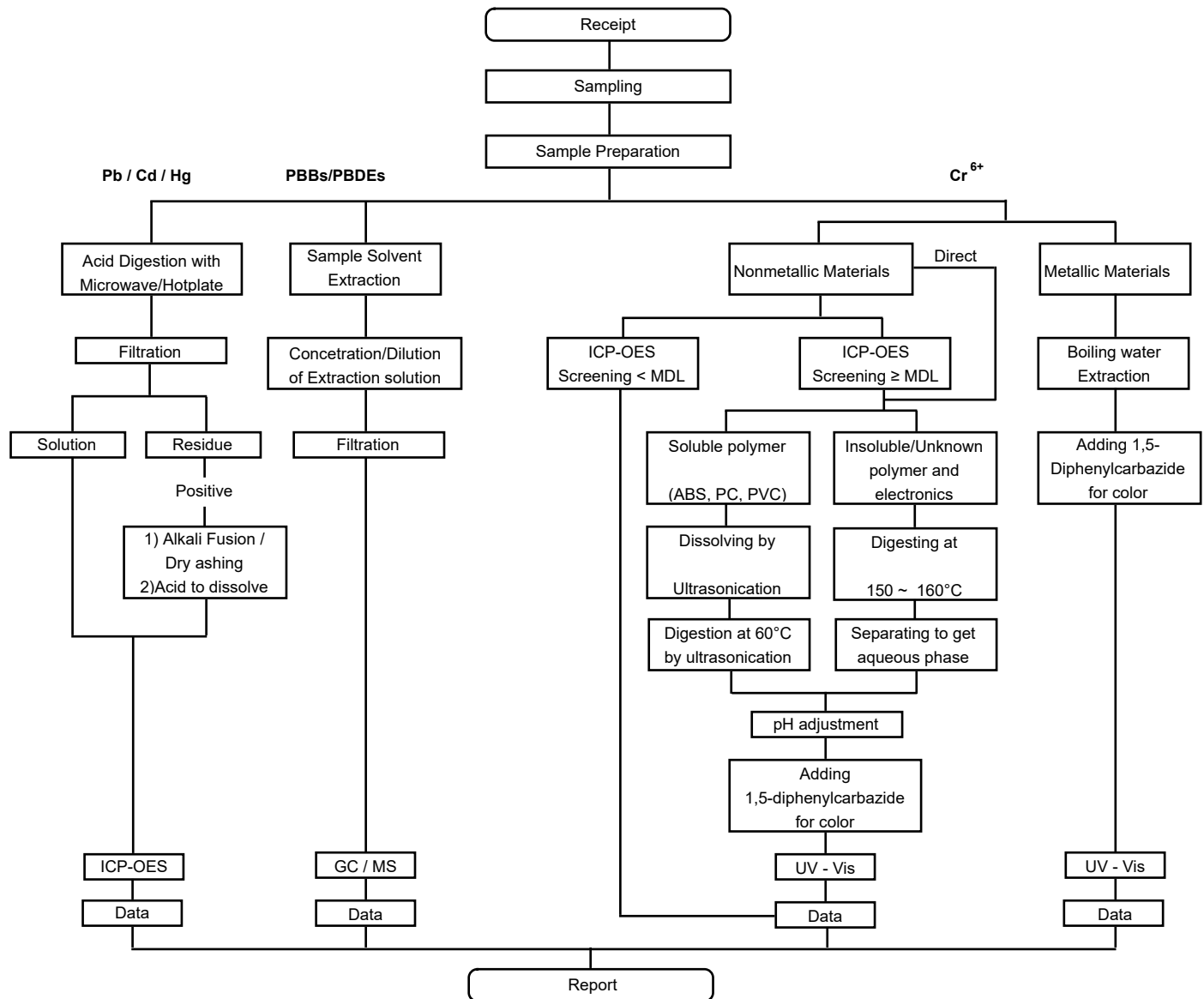

Picture of Sample as Received:



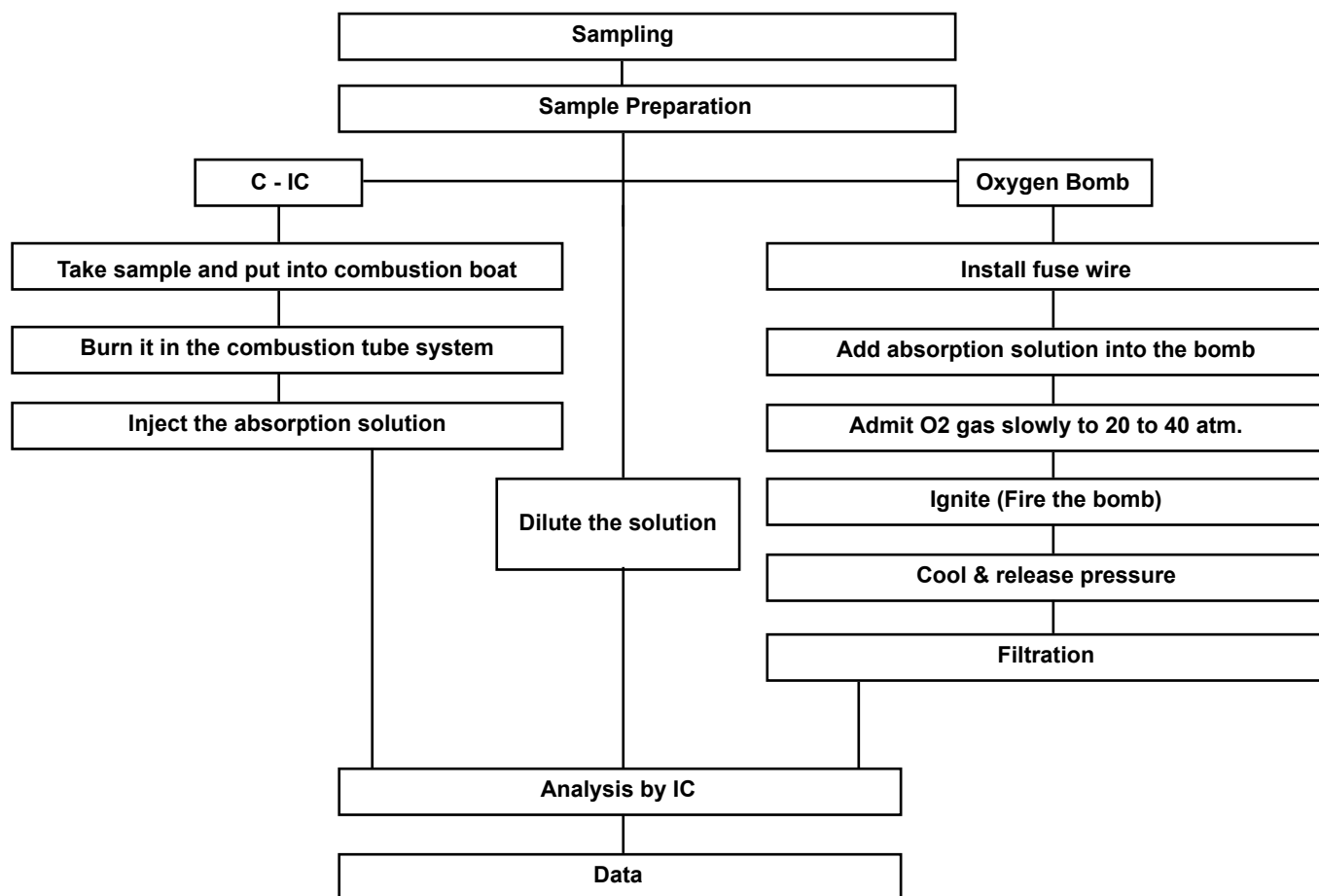

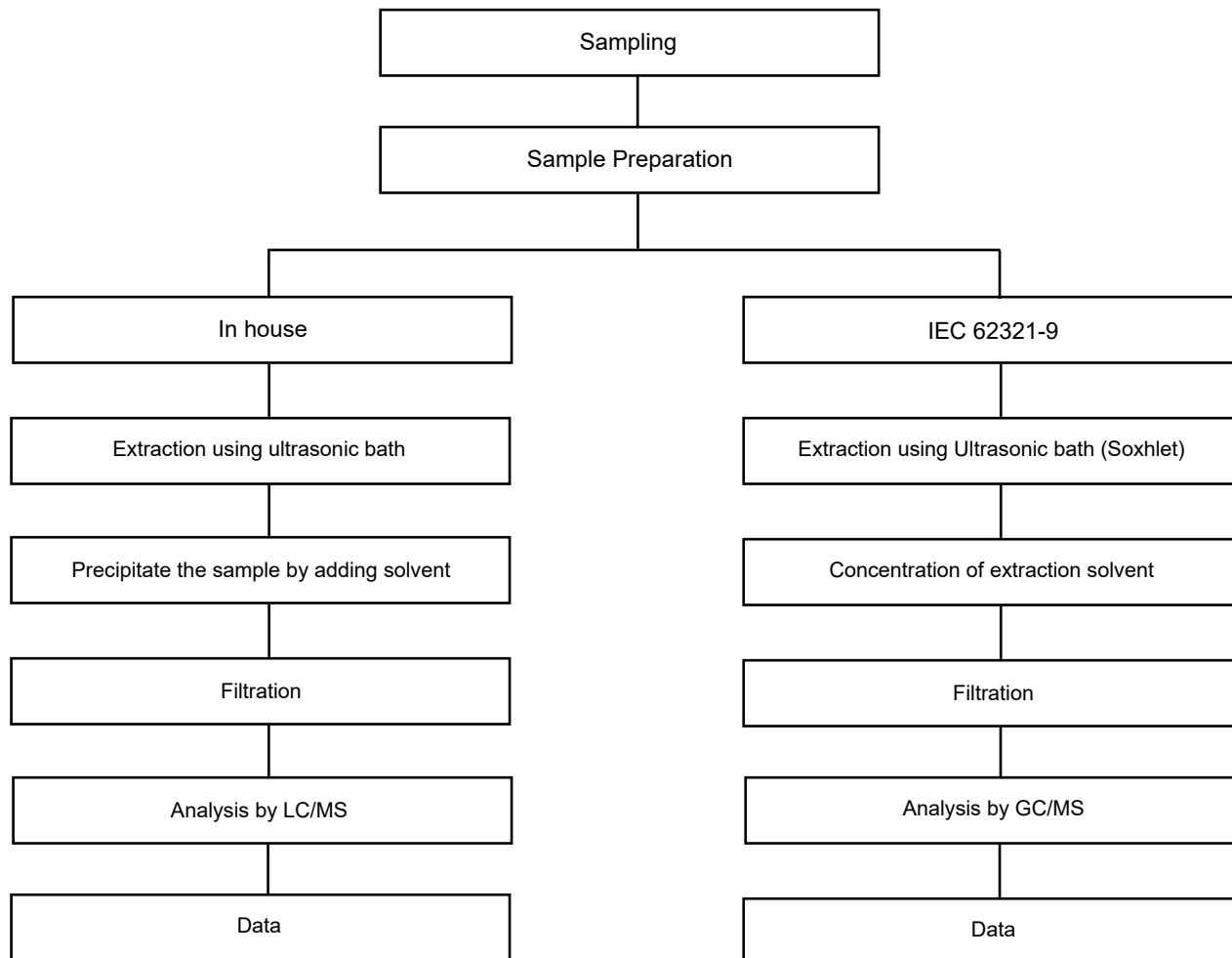
Flow Chart for RoHS Pb / Cd / Hg / Cr⁶⁺ / PBBs&PBDEs Test

Flow Chart for Halogen Test



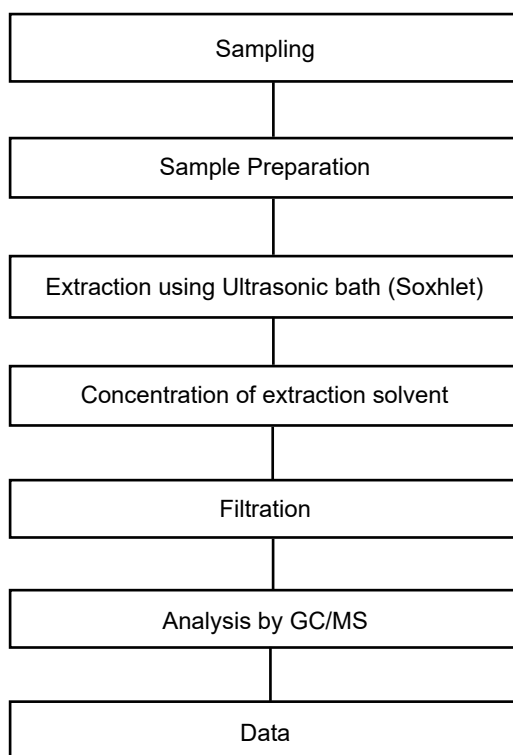
