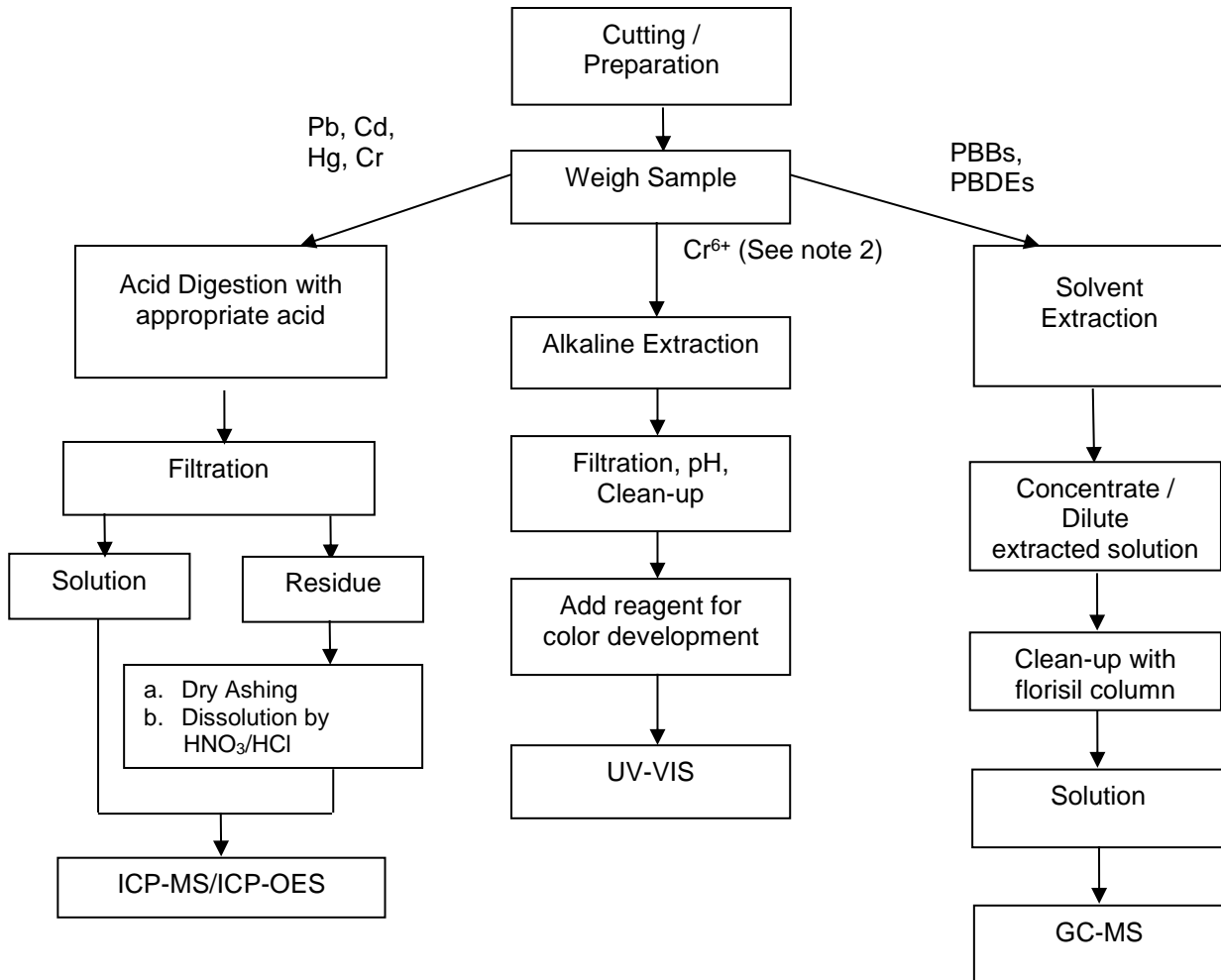

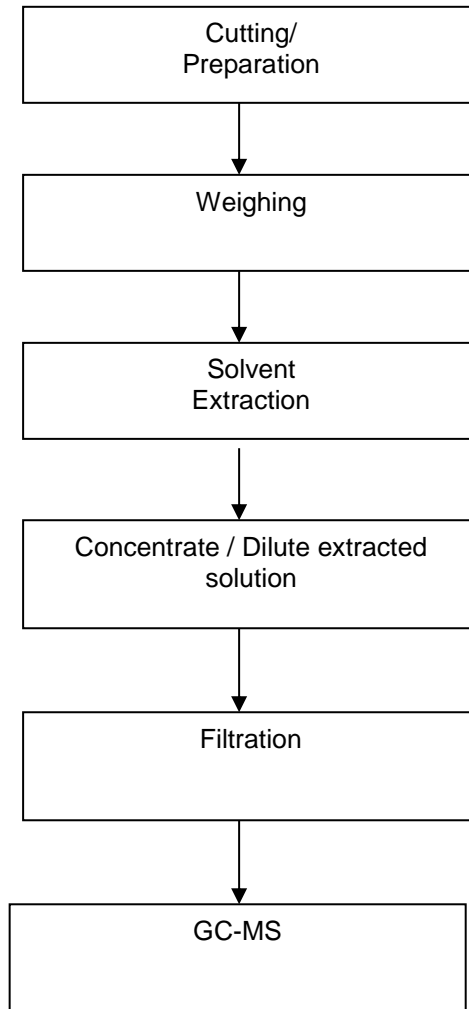
Flowchart for ROHS Testing:
