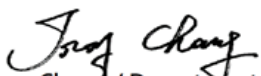

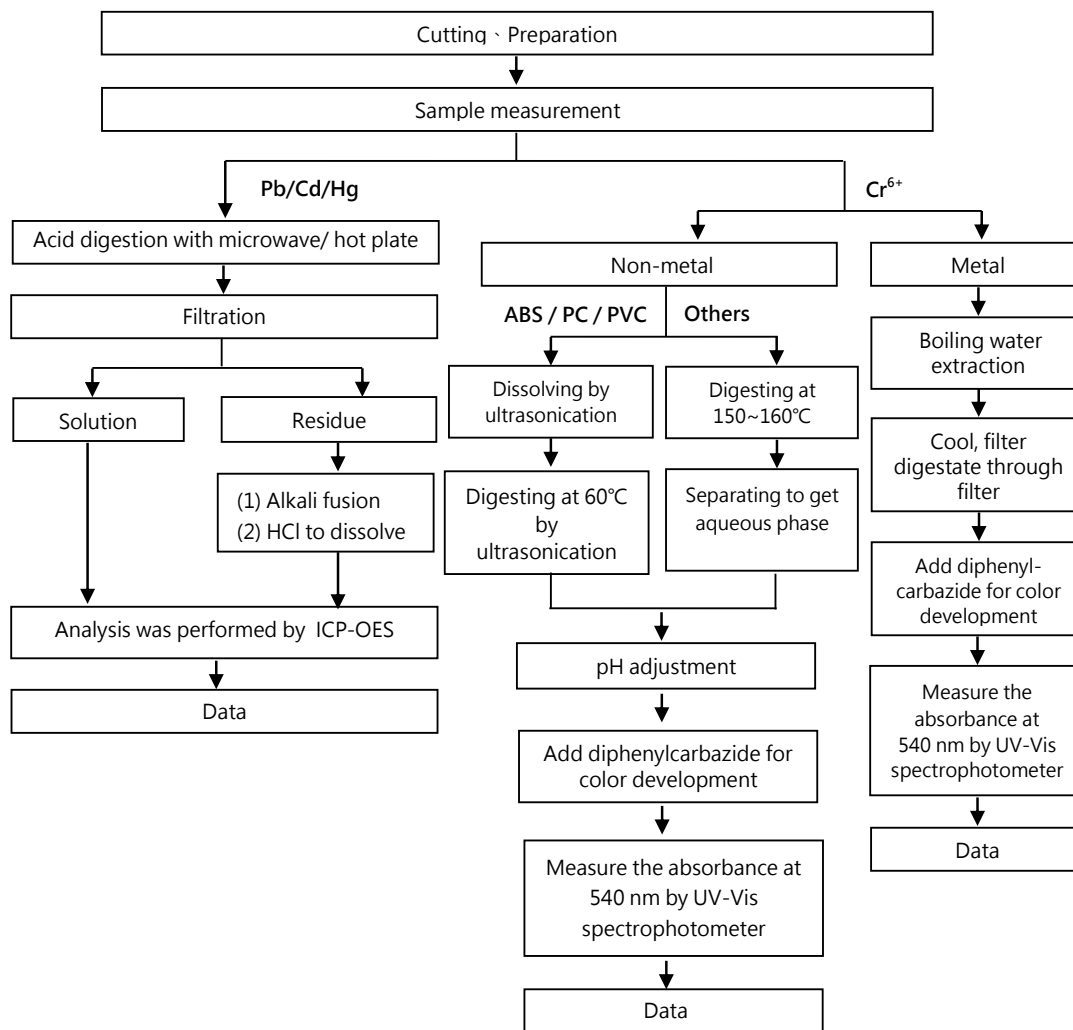

Analytical flow chart of heavy metal

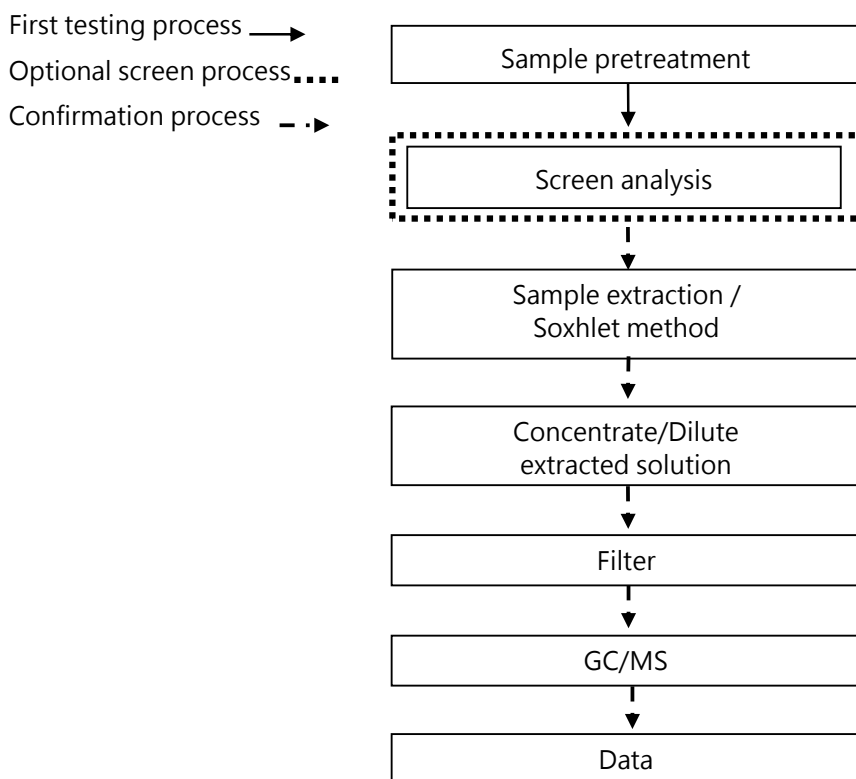

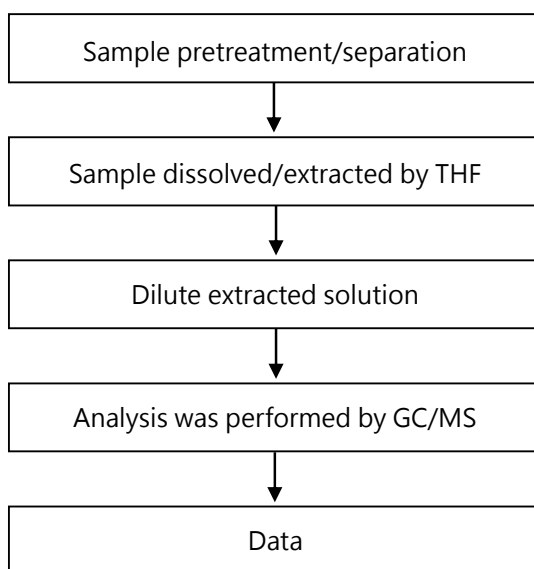
Analytical flow chart – PBBs / PBDEs

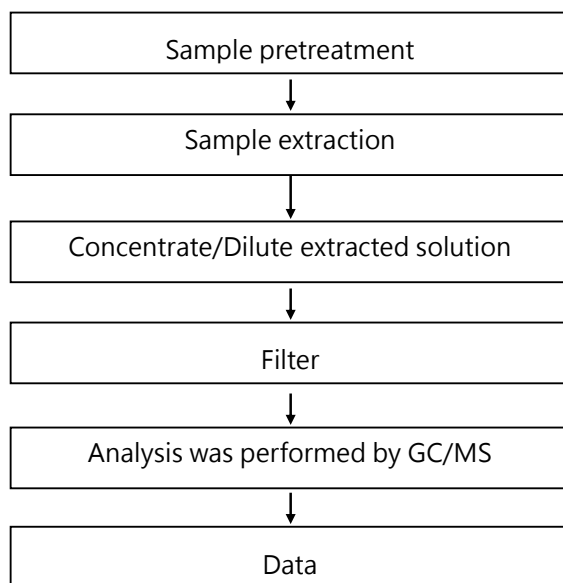

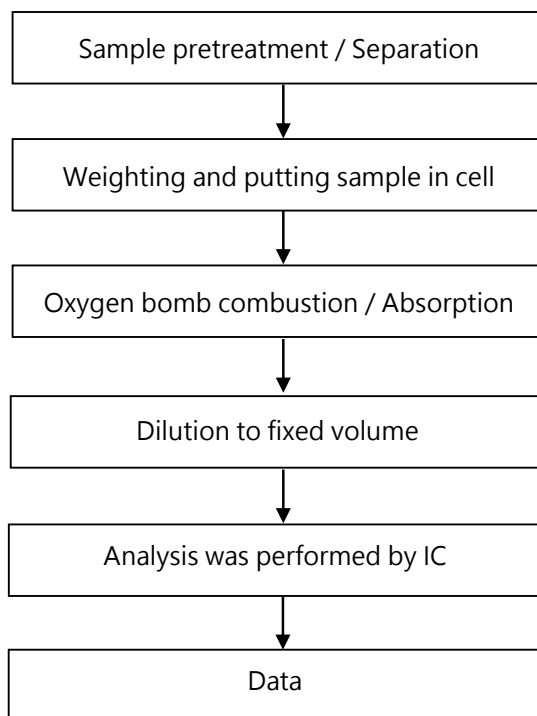

Analytical flow chart - Halogen

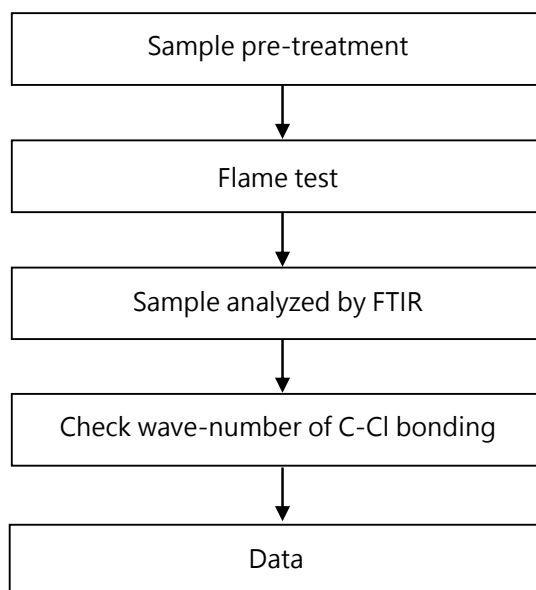

Analysis flow chart - PVC

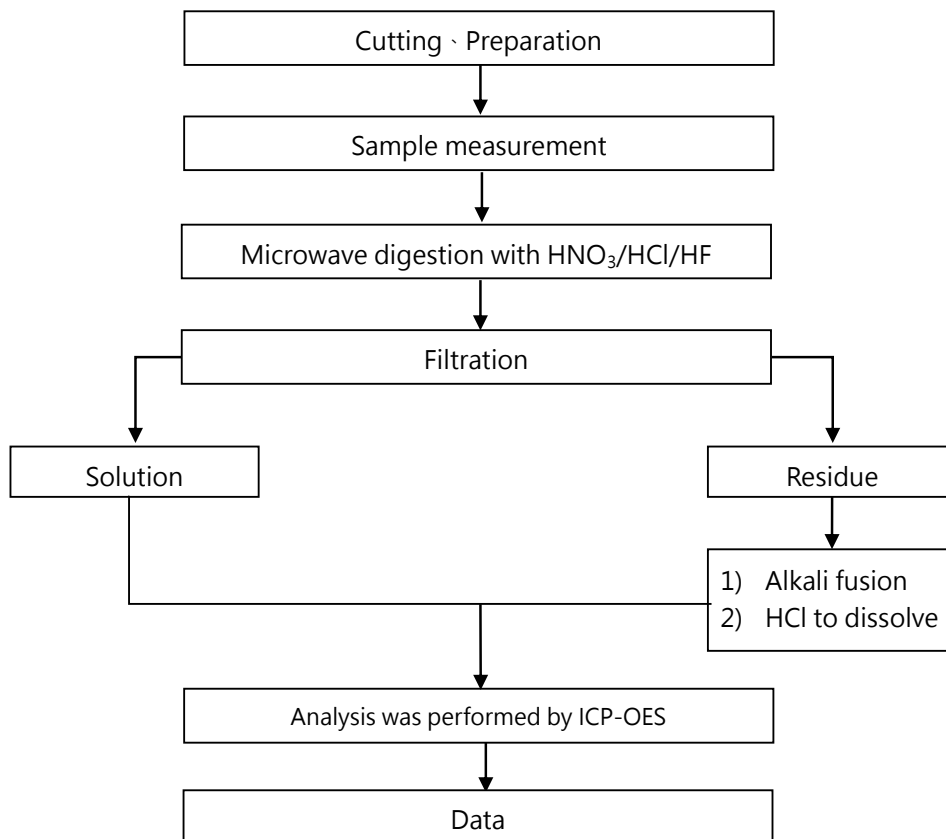

Analytical flow chart of elements (Heavy metal included)

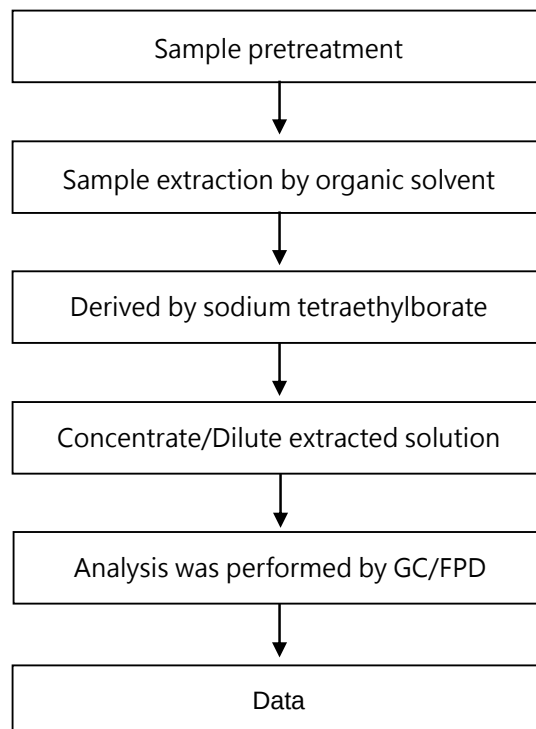

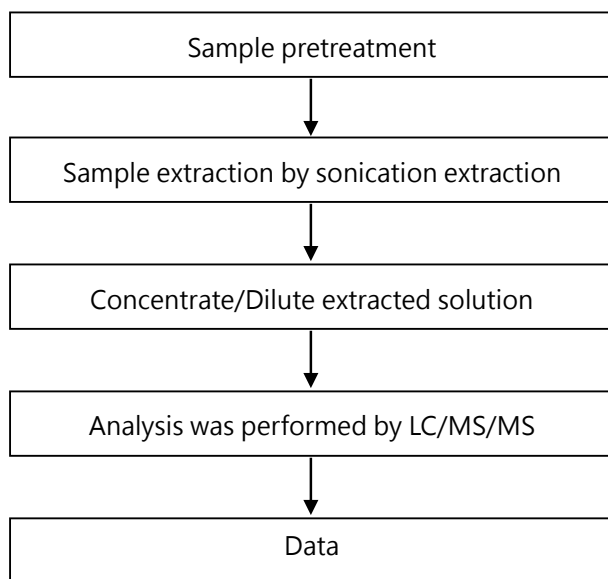

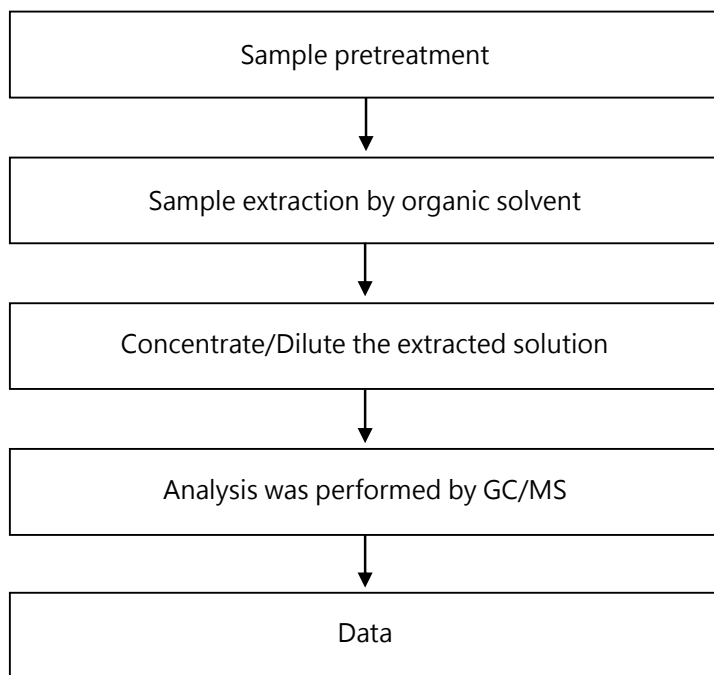
