### 四溴雙酚-A分析流程圖 / TBBP-A analytical flow chart

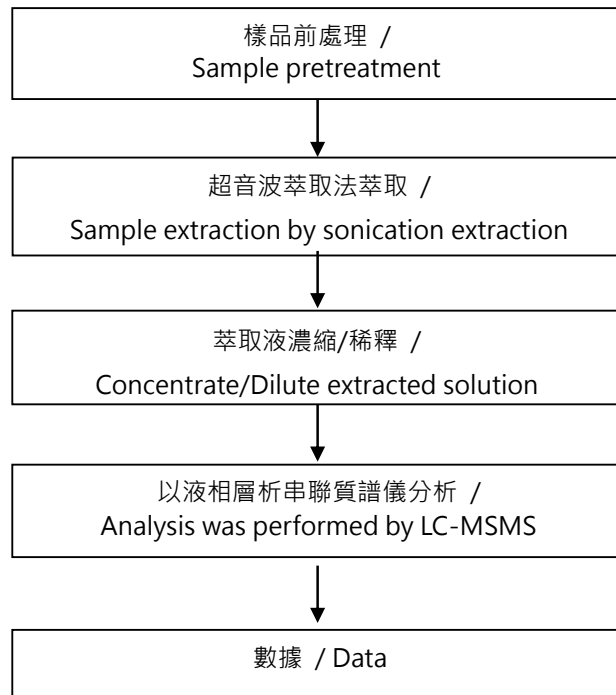

### 雙酚A分析流程圖 / Bisphenol A analytical flow chart



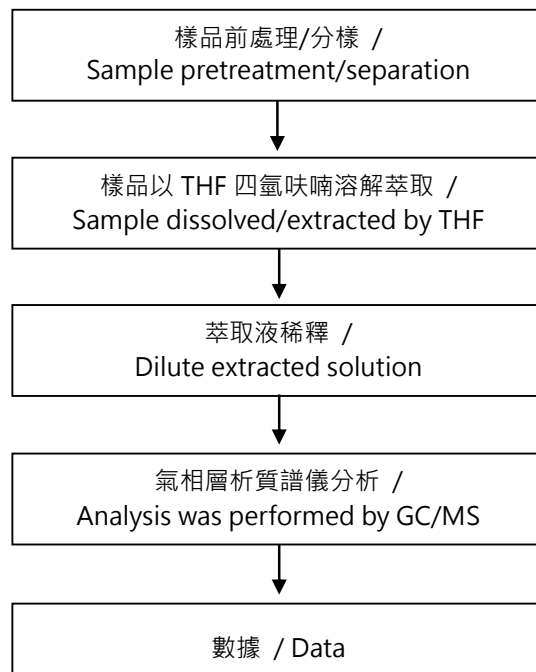
