





## **PBBs/PBDEs Testing Flow Chart**







## **Phthalates Testing Flow Chart**



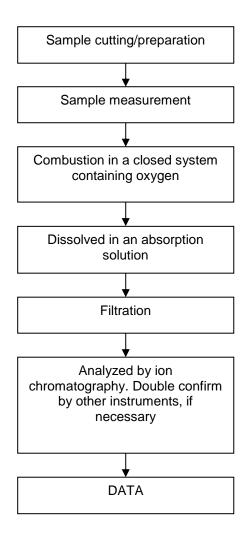

## **Halogen Testing Flow Chart**






